**(Philadelphia, PA) – INGLIS FOUNDATION**, which provides programs and services to enable people with physical disabilities, and those who care for them, to live life to the fullest, announced new leadership for **INGLIS HOUSE**. **MARJORIE Y. HARDING, RN, BSN, MBA** has been promoted to Co-Executive Director and Director of Nursing; while **WILLIAM GRIM, NHA** has been named Co-Executive Director and Administrator.

“These new appointments will strengthen our leadership team,” said **Gavin Kerr, INGLIS FOUNDATION** President and CEO. “Both Marjorie and Bill share a deep commitment to helping people with disabilities and those who serve them, live great lives. They both have strength of character and give much more of themselves than we could ever ask,” said Kerr.

Establishing the Co-Executive Director structure recognizes the strong, peer-level partnership needed between operations and clinical services and allows shared accountability for the day-to-day leadership of **INGLIS HOUSE**. “I was truly impressed by the quality of the working relationship Marjorie and I enjoyed during my six-month interim term,” said **Grim**. “I am very fortunate,” said **Harding**, “to be able to work closely with Bill to help make a difference in the lives of our consumers who live at Inglis and the staff who work here.”

**INGLIS FOUNDATION** enables people with physical disabilities and those who care for them to achieve their goals and live life to the fullest. **INGLIS HOUSE** is a specialty nursing care facility providing long-term, residential care for 297 adults with complex physical disabilities. It offers long-term, rehabilitative medical and nursing care; physical, occupational and speech therapies; and social enrichment programs. In addition to **INGLIS HOUSE**, **INGLIS FOUNDATION** also offers services for those living independently in the community including accessible housing, care management, adult day care and community employment. All Inglis' services and programs are designed to enable people with physical disabilities to enjoy life with the greatest amount of independence and mobility.

**WILLIAM GRIM** brings a lifetime of experience in long-term care to his new role as Co-Executive Director of Inglis House, having served in nearly every operations role in a nursing home including many front-line staff roles. Most recently, Grim spent 18 years as the Executive Director and then as CEO, for Saunders House and Bryn Mawr Terrace: facilities providing long-term care and rehabilitative services involving community-based education. He also served on the PA State Board of Examiners of Nursing Home Administrators and as Executive Director/Corporate President for the Devon Manor Corporation, a privately held continuing care retirement community. Grim has demonstrated a deep commitment to people living with disabilities through his volunteer work with the Devereux Foundation, the ARC of Chester County and the Chapin Foundation for the Aged Blind.

Born in Jamaica, **MARJORIE HARDING** came to the United States during the 1980s. She was trained as a licensed practical nurse at Presbyterian Medical Center of the University of Pennsylvania; earned an associate's degree in nursing from Delaware County Community College; a bachelor of science in nursing from Hahnemann University Hospital; was designated as an MS Nurse Specialist by the National Multiple Sclerosis Society; and most recently, earned her MBA from Eastern University. Like her academic achievements, Harding's career at Inglis House reflects her passion for nursing and penchant for professional growth. She came to Inglis in 2000 as a nurse unit manager before becoming a community administrator. Prior to her recent appointment as Co-Executive Director of Inglis House, Harding served as director of nursing since 2008.
