Thanks to a **Pennsylvania Department of Health** grant, people with disabilities and their caregivers will have direct internet access to **EASI** (Exploring Access to Services for Independence). The database was initially developed by Inglis Care Management staff to help them find client services in the Philadelphia region. With this technology, people with disabilities can more easily find the services



they need, whether it's a health care provider or a hair salon with an accessible entrance. Inglis Care Management staff will continue to provide one-on-one assistance to clients.

Inglis House offers religious services and group activities for all residents across 17 declared denominations. The many programs and groups are extremely important to residents – registering total attendance of more than 10,000 during the year. This year the **T. James Kavanagh Foundation** provided a grant to support Inglis’ pastoral care program and purchase liturgical items for worship and prayer services.

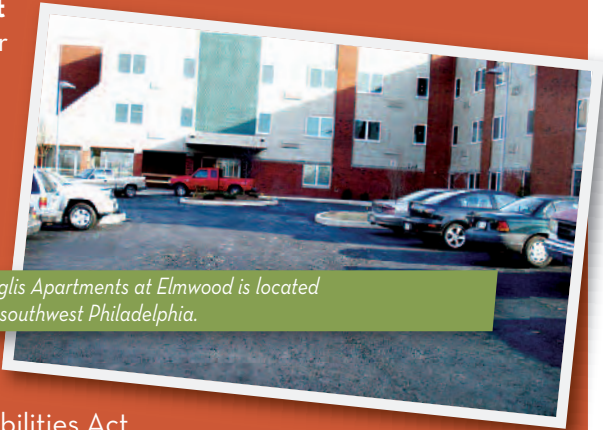

Imagine the isolation and frustration felt by someone with a physical disability who is unable to flip a light switch or turn on a TV. Not being able to perform these tasks of daily living can profoundly affect feelings of self worth, as well. With a grant from the **George W. Rentschler Foundation** Inglis House staff have purchased a variety of electronic switches that help residents with extremely limited manual dexterity perform their daily tasks. Staff can use these switches to evaluate which is most helpful for a specific resident. After the assessment, staff can customize residents' wheelchair controls and electronic and personal care applications to meet their needs.
